Sub: B.I.E., A.P., Vijayawada– Notification for extension of provisional affiliation and sanction of additional sections in Andhra Pradesh State from the academic year 2018-2019 to 2021-2022 (4 Years) –Applications are invited from the managements of existing Private Aided / Unaided Jr. Colleges (including composite colleges) / Co-operative / Incentive / A.P. Social Welfare / A.P. Tribal Welfare / A.P. Residential Junior Colleges / Kendriya vidyalayas – Intimation to all the Junior Colleges in their jurisdiction –Reg.

All the Regional Inspection Officers, Board of Intermediate Education, Andhra Pradesh are hereby informed to intimate all the Principals & Managements of existing Private Aided / Unaided (including Co-op.) / Incentive / APSWR / APTWR / APRJC / Kendriya Vidyalayas in their jurisdiction that they should submit online applications for 4 years with an option to the managements to apply for a minimum period of 2 years and maximum period of 4 years from the academic year 2018-19 onwards for extension of provisional Affiliation & Sanction of Additional Section will be available in the website: www.apbie.apcfss.in in college services of BIE, AP from 05-03-2018. Further the Regional Inspection Officers are also instructed to issue a circular and give wide publicity for the submission of affiliation proposals in time with all the required documents through online. For sanction of P.A. every year through online all the college Managements are directed to upload the details with valid documents every year, even if they already paid the Affiliation fee upto 2022.

The RIOs are instructed to inform all the Principals that they should not open new sections without the prior sanction from the Secretary, BIE, A.P. Vijayawada. Any such deviation will be viewed seriously, which will make them liable for disaffiliation besides imposition of penalty under A.P. Education Act and the rules made there under. Also instruct all the Principals / Managements not to submit the manual proposals directly to Head Office. Such proposals will be rejected. **The Principals are not allowed to enter the admission particulars/ details of the candidates in excess of 88 strength. Provision to enter**

admission details of additional sections will be provided only after obtaining sanction order from BIE.

The RIOs are directed to instruct the managements to upload the details in online along with all the required documents. The R.I.O in turn should verify all the applications forms thoroughly with regards to RCC accommodation, addl. accommodation for addl. sections, FDR inforce, Registered Lease Deed of building & Playground inforce, Approved building plan, Fire Safety Certificate, Sanitary Certificate, Structural Soundness Certificate, Parking area, employees details etc., as per norms and recommend to the head office for its sanction through on-line.

The last date for on-line applications without penalty is 05-04-2018 and with penalty is upto **06.07.2018**. The due dates with penalty are furnished here under.

The RIOs are directed to instruct the managements to upload the prescribed data through online for extension of Provisional Affiliation including sanction of Additional Sections, from the official website (www.apbie.cfss.in) of Andhra Pradesh State Board of Intermediate Education with effect from 05/03/2018 and the payment of fees is by the way of **SB Collect through on-line link provided by APCFSS.**

The College Managements who have not paid the affiliation fee in the previous years are permitted with a penalty of Rs. 30,000/- per year with affiliation fees and they can upload their details through online.

The RIOs are directed to instruct the managements to submit affiliation proposals through online only. Any manual proposal submitted directly to the head office will be summarily rejected.
